In terms of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 Dated:- 22.02.1994 recast vide SRO-201 of 2007 Dated:- 04.06.2007, sanction is hereby accorded to the temporary appointment of Sh.Shubam Kohli, S/o Late Sh. Pardeep Kumar Kohli R/o H.No:- 382 Bakshi Nagar, Jammu as Attendant (Class-IV) in the Pay Scale 14800-47100 Level: SL1 as his father who was working as Attendant(I/c Junior Assistant) in this department died in harness on 16.05.2019.

The appointee is posted as Attendant (Class-IV) against the available vacant post of Attendant in the office of Poultry Nutritionist, Jammu.

The appointee shall report to Poultry Nutritionist, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates:

- 1/ Academic Qualification certificate.
- 2/ Date of Birth Certificate.
- 3/ Health Certificate issued by the CMO.
- 4/ Permanent Resident Certificate.
- 5/ Character Certificate.
- 6/ Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.

The appointment shall be subject to the following conditions:-

- a/ The appointee shall give an undertaking in the shape of an Affidavit to the effect that in case adverse report about his character and antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the DDO, the candidate shall have no right to claim his appointment as Attendant (Class-IV) and his appointment as such shall be deemed to have been cancelled ab-initio.
- b/ The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of character and antecedents is received from the Competent Authority.
- c/ Verification of Qualification/Date of Birth certificate from the concerned issuing authorities.  
If on verification, the certificates produced by the appointee regarding qualification and date of birth are proved fake or forged, the appointment shall be cancelled ab-initio.  
The appointee shall be on probation for a period of two years.
