Sanction is hereby accorded to the temporary appointment of Sh. Rijjwal Jamwal S/o Late Sh. Surinder Singh R/o Barnoti Tarhara Tehsil & District Kathua as Attendant (Class-IV) – District Cadre, Kathua in the Pay Scale 14800-47100 Level: SL1 under SRO-43 of 1994 Dated:- 22.02.1994.

The appointee is posted as Attendant (Class-IV) against the available vacant post of Attendant in the organisation of Chief Animal Husbandry Officer, Kathua.

The appointee shall report to Chief Animal Husbandry Officer, Kathua within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:

- 1/ Academic Qualification Certificate.
- 2/ Date of Birth Certificate.
- 3/ Health Certificate from the concerned Chief Medical Officer.
- 4/ Dependent Certificate issued by the concerned Assistant Commissioner, Revenue.
- 5/ Character Certificate.
- 6/ Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.
- 7/ Domicile Certificate issued by the concerned Competent authority.
- 8/ All other relevant documents as are required under SRO-43 of 1994.

The appointment of the appointee shall further be subject to the following conditions:-

- a/ The appointee shall give an undertaking in the shape of an Affidavit to the effect that:
 - (i) In case adverse report about his Character and Antecedents is received from the Inspector General of Police, CID, J&K to whom a reference shall be made by the DDO, the candidate shall have no right to claim his appointment as Attendant (Class-IV) in the department and his appointment as such shall be deemed to have been cancelled ab-initio.
 - (ii) If on verification, genuineness of the qualification certificates produced by the appointee regarding qualification and date of birth certificate from the concerned issuing authority is found fake/forged, the appointment of the appointee shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b/ The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of (i) and (ii) above are received from the Competent Authorities.
- c/ The appointees shall be governed in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O.No:-192 of 2020 Dated:- 17.06.2020.
- d/ If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, his appointment shall be deemed to have been cancelled ab-initio without any further notice as per the Circular No:- 08-JK(GAD) of 2019 Dated:- 04.12.2019.
