- Certificate from concerned authorities to the effect that no loan under Self 6. Employment Scheme has been obtained/ availed by the concerned candidate.
- Undertaking regarding no criminal records 7.
- Any other relevant certificate as required under rules. 8.

The appointment shall further be subject to the following conditions:-

The appointee(s) shall be on probation for a period two years and the salary of appointee(s) shall not be drawn and disbursed to him/her unless a

satisfactory verification report in respect of academic qualification/other certificates is received from the concerned authority.

- ii) The inter-se seniority of the candidates shall be reckoned as per the merit furnished by the J&K SSB.
- iii) The appointments shall be cancelled ab-initio, if it is found that the candidate is having higher qualification than the prescribed one at any stage later on, he/she shall also be liable for criminal prosecution.
- iv) The appointment order shall be subject to outcome of any petition(s) pending in any competent court/Tribunal etc.
