The Gram Sabha is the finest mechanism for ensuring accountability and transparent functioning of Government schemes, and the Department of Animal Husbandry and Dairying, Government of India, would like to utilize this opportunity to ascertain the level of performance of its flagship Nationwide Artificial Insemination Programme (NAIP) under which free Al services are being provided to dairy farmers in all districts of participating States.

NAIP is a campaign mode programme for genetic upgradation of bovines through A.I. with semen of high genetic merit bulls, to get the best productivity. The rationale behind implementing the programme is to enhance the milk production of the States through use of A.I, the appropriate and low cost breeding technology available for improving the genetic merit of milch animals.

The activities under the NAIP are recorded by field level workers in real time directly into the INAPH (Information Network for Animal Productivity & Health) data portal maintained by NDDB (National Dairy Development Board) on behalf of the Department.
