

Sub:- Issuance of tentative seniority list of **Electrician** (Pay Level-4) – Divisional Cadre, Animal Husbandry Deptt., Jammu, as it stood on 01.01.2022.

NOTIFICATION

1. Whereas, it has become expedient to notify the seniority list of Electrician (Divisional Cadre) of Animal Husbandry Department, Jammu for information of concerned official;
2. Now, therefore, tentative seniority list of Electrician of Animal Husbandry Department, Jammu as it stood on 01.01.2022 is notified as Annexure, for information of concerned. The official aggrieved of his position assigned in the tentative seniority list can make a representation to this Directorate, within a period of 21 days, from the date of issuance of this notification with supporting documents. In case, the official chooses not to file any objection, it shall be construed that there is nothing objectionable against the seniority position and final seniority list shall be issued, accordingly.
3. It is, further, notified that:-
 - (i) the date of birth recorded against the official in the tentative seniority list, so notified, shall not be taken as authentic and shall be subject to the verification from the Service Book/Matriculation Certificate;
 - (ii) the concerned Controlling Officer shall furnish the details of the official in whose favour period of unauthorized absence is yet to be decided and also intimate the details of the official whose period of absence has been treated as Dies-Non. Besides, to furnish the details/information connected with the updating of the seniority list, if any;
 - (iii) the concerned Controlling Officer shall maintain a separate register of objections to be received, within the stipulated time and inform this Directorate, accordingly, after scrutiny of each objection with specific recommendation;
 - (iv) the concerned Controlling Officer shall serve the tentative seniority list to the Electrician working in his organization.
4. The concerned official can access the tentative seniority list on the official website "**animalhusbandryjammu.nic.in**".
5. This issue without prejudice to the outcome of writ petition(s), if any, pending before any competent Court of Law.






