Sub:- Veracity of Government Orders with regard to appointment made under Sports Quota and termination of service thereof.

## **ORDER NO:- 39 -DAHJ OF 2022**

## DATED:- 22 -10-2022

Whereas, Sh. Ravinder Kumar S/o Sh. Baldev Raj R/o Village Dilli, PO Channi Himmat Ext. Tehsil & District Jammu joined in this department on 04.06.2016 claiming to have been appointed as Class-IV vide Government Order No:- 637-GAD of 2016 dated:- 16.05.2016 under Sports Quota;

Whereas, Administrative Department vide letter No:- ASH/AH/Cood/01/ 2020 dated:- 28.02.2020 requested the department to furnish the information regarding employees appointed under Sports Quota, as desired by the General Administration Department, J&K vide O.M.No:- GAD/Mtg/Sports/09/2019 dated:- 26.02.2020;

Whereas, vide this office letter No:- DAHJ/P-31(N)/2019-20/13730 dated:- 03.03.2020 Administrative Department was intimated that Sh. Ravinder Kumar had been appointed under Sports Quota vide Government Order No:- 637-GAD of 2016 dated:- 16.05.2016 as Class-IV and is presently posted in Directorate of Animal Husbandry, Jammu;

Whereas, Administrative Department vide letter No:- GAD-MTG0SPRT/ 13/2021-09-GAD dated:- 24.12.2021 again requested to furnish the information as desired by the General Administrative Department, J&K vide O.M. No:- GAD-MTG0SPRT/13/2021-09-GAD dated:- 21.12.2021 with regard to appointment made under Sports Quota;

Whereas, vide this office letter No:- DAHJ/Adm-172/26842 dated:-17.01.2022, it was intimated to the Administrative Department that the desired information stands already submitted vide letter No:- DAHJ/P-31(N)/2019-20/13730 dated:- 03.03.2020;

Whereas, Administrative Department vide letter No:- ASHF-CORD/105/ 2021-03 dated:- 19.05.2022 addressed to the Additional Director General of Police, Crime Branch, J&K with a copy to this department has intimated that :-

"I am directed to forward herewith a copy of O.M.No:- GAD-MTGOSprt/13/2021-09-GAD dated:- 09.05.2022 alongwith its enclosures received from the General Administration Department regarding the subject cited above and to say

that the General Administration Department vide O.M. dated:- 21.12.2021 sought the details of officials of Animal/Sheep Husbandry & Fisheries Department, who were appointed under sports quota. Accordingly, the matter was taken up with all the HoDs of the Department viz Director, Animal/Sheep Husbandry, Jammu/Kashmir and Director Fisheries J&K. In response Director, Animal Husbandry, Jammu have intimated that one Shri Ravinder Kumar has been appointed as Attendant in Animal Husbandry Department, Jammu under sports quota vide Government order No:- 637-GAD of 2016 dated:- 16.05.2016 (copy enclosed).

Consequently, the said information was shared with the General Administration Department vide this department's O.M.No:- ASHF-CORD/105/2021-03 dated:- 30.03.2022 alongwith G.O.No:- 637-GAD of 2016 dated:- 16.05.2016 (copy enclosed).

Furthermore, the General Administration Department vide O.M. No:- GAD-MTGOSprt/13/2021-09-GAD dated:-09.05.2022 has intimated that the Government Order No:-637-GAD of 2016 dated:- 16.05.2016 does not pertain to appointment of Mr. Ravinder Kumar S/o Sh. Baldev Raj R/o Village Dilli, P.O.Channi Himat Ext. Tehsil & District Jammu as Class-IV but actually pertains to the subject : "On the Job Practical Training of the Junior Scale KAS Probationers of 2015".

In view of the above details, it is therefore requested to kindly investigate the matter in depth, so that further action may be taken in the matter accordingly."

and the department was requested to take further necessary action under rules in the matter;

Whereas, pending enquiry, into the matter by the Crime Branch, J&K, Sh. Ravinder Kumar S/o Sh. Baldev Raj R/o Village Dilli, P.O.Channi Himmat Extension, Tehsil & District Jammu was placed under suspension w.e.f. 20.05.2022 A.N. vide Order No:- 15-DAHJ of 2022 dated:- 27.07.2022;

Whereas, Administrative Department vide letter No:- ASHF-CORD/ 105/2021-03 dated:- 02.09.2022 has intimated that the suspension of Mr. Ravinder Kumar is not valid, as the official has managed to enter into Government employment on the basis of fake appointment order and his appointment is non existent ab-initio. Accordingly, department has been directed to discharge the fake employee and recover the dues received by him from the department through fraud; Whereas, the matter with regard to recovery of dues received by Sh. Ravinder Kumar from this department w.e.f. 04.06.2016 (from the date of his joining in the department) was taken up with the concerned Drawing & Disbursing Officer (Accounts Officer, Directorate of Animal Husbandry, Jammu), who has intimated that he has received an amount of Rs.13,84,379.00 (Rupees Thirteen lakhs eighty four thousand three hundred and seventy nine only) as wages during the period of his illegal appointment.

Now, therefore, in light of the aforementioned background, the services of Sh. Ravinder Kumar S/o Sh. Baldev Raj R/o Village Dilli, PO Channi Himmat Extension, Tehsil & District Jammu who had secured job on forged order are hereby terminated, as his appointment is void ab-initio. The amount of Rs. 13,84,379.00 (Rupees Thirteen lakhs eighty four thousand three hundred and seventy nine only) received by him through deceived means from this department shall be recovered after following due process of law.
