Sub:- Appointment of Veterinary Pharmacists in Animal Husbandry Department, Jammu.

ORDER NO:- 209 DAHJ of 2017

DATED:- 9 -02-2017.

As recommended by the J&K Service Selection Board, J&K and in reference to this office Notification No:- DAHJ/Adm-1056/9491-94 Dated:- 12.01.2017, sanction is hereby accorded to the appointment of 04 candidates who reported in this Directorate alongwith documents within stipulated time as Veterinary Pharmacists in the Pay Band of 5200-20200 + GP 2400/- in Animal Husbandry Department, Jammu as indicated in the Annexure to this order against the available vacancies. The appointment of these candidates shall be regulated in terms of SRO 202 dated: 30.06.2015.

The appointee(s) shall be initially on probation for a period of five years.

The appointee(s) shall have to necessarily work for a period of five years on the post against which he/she has been appointed and such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years.

The appointee(s) appointed on the basis of being a resident of backward area or an area adjoining to Line of Actual Control shall serve in such areas for a period of not less than seven years.

During the period of first five years, the appointee(s) shall be entitled to the minimum of scale of pay alongwith the grade pay applicable to the post against which appointed. The appointee shall after completion of five years period on probation be entitled to fixation of pay in the pay band applicable to the post against which he/she is appointed.

The appointee (s) shall have to undergo one year Stock Assistant Training Course.

The appointee(s) shall be entitled to annual increments, Dearness allowance, House Rent Allowance and City compensatory Allowance after successful completion of his/her five years service on consolidated salary.

The appointee(s) shall be entitled to the benefits under the Medical Attendance Rules and Leave Rules from the date of his/her appointment itself.

The seniority of the appointee(s) appointed under these rules shall reckon from the date of their appointment. The period spent on probation/consolidated salary shall also reckon for purposes of calculating the qualifying service of the appointee for pensioner and other benefits provided under rules. The appointee(s) shall report to the concerned Chief Animal Husbandry Officer/Liverfluke cum Rinderpest Control Officer, Jammu within a period of 21 days who will allow them to join at their place of posting only after production of following certificates/testimonials in original:-

1. Academic Qualification Certificate.
2. Matriculation/Date of Birth Certificate.
3. Health Certificate issued by the CMO
4. Permanent Resident Certificate.
5. Technical Qualification, if any.

6. Character Certificate.
7. Relevant Category Certificate (in case of candidates belonging to reserved categories)
8. Certificate from the General Manager DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.
9. Undertaking on an Affidavit duly attested by the First Class Judicial Magistrate to the effect that the documents submitted are genuine and in case the documents proved fake or forged at any stage, the appointment shall be liable for cancellation ab-initio.
10. In case any appointee fails to join within the period of 21 days his/her appointment shall be deemed to have been cancelled without any further notice.

The appointment shall be subject to the following conditions:-

a/ Each appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case of any adverse report about his/her character and antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the concerned DDO, the candidate shall have no right to claim his/her appointment as Veterinary Pharmacist and as such shall be deemed to have been cancelled ab-initio.

b/ Verification of qualifications/Date of birth certificate from the concerned issuing authorities.

c/ The salary of the appointees shall not be drawn and disbursed to them unless satisfactory report in respect of their character and antecedents is received from the competent authority.

This issues without prejudice to the outcome of writ petition pending if any, before any competent court of law and shall be subject to the outcome of such writ petition.


