**PUBLIC NOTICE**

The Administrative Department Animal/Sheep Husbandry & Fisheries, Govt. of Jammu & Kashmir has constituted **Registration Tribunal** vide S.O.-236 dated 23.07.2020 issued under endorsement No. ASH/Coord/261/85-III dated 23.07.2020 with the mandate to prepare the **First State Veterinary Register** in the union Territory of Jammu & Kashmir. Accordingly, it is enjoined upon all desirous persons seeking registration under "**The Indian Veterinary Council Act, 1984**" that:

1) **Registration of Eligible Persons under Indian Veterinary Council Act, 1984 :**

Every person who is residing in Jammu and Kashmir and possessing a "**recognized Veterinary qualification**" from a **recognized "veterinary institution"** as required under the Indian Veterinary Council Act, 1984, shall apply for registration to the Registration authority constituted by the Government of Jammu and Kashmir in the prescribed form. Every such application shall be accompanied by:-

- i) Proof of Date of Birth (Matriculation or Secondary Examination Certificate in original along with two attested copies thereof).
- ii) Degree/Diploma Certificate in original along with two attested copies thereof).
- iii) A fee of Rs. 25.00 (Rupees Twenty Five only) through Bank Demand Draft/e-transfer in favour of Registrar, Jammu & Kashmir Veterinary Registration Tribunal payable at J&K Bank, Talab Tillo, Jammu.
- iv) Three Passport sized coloured photographs, duly self-attested on the backside of the photograph.
- v) Permanent Address Proof.

2) **Renewal of Registration certificate:**

Upon issuance of notification in the official Gazette by the Government directing the retention of name in the State Veterinary register, Every registered practitioner registered under section 44 of the Act shall renew his registration after every five years, by making an application to the Registrar accompanied by the Fee Rs. 15 prescribed under rule 48 (1) of the Act, and such renewal fee shall be due to be paid before the 1st day of April of the year to which it relates. When a renewal fee is not paid within the said period, the name of the defaulter shall be removed from the State Veterinary register under rule 48 (2) of the Indian Veterinary Council Act, 1984. The name so removed may be restored to the said register on payment of renewal fee in such manner as may be prescribed.

### **3) Transfer of Registration:**

Any registered veterinary practitioner registered in the other state and practicing veterinary medicine in the state can apply for registration in the prescribed form for transfer of his name from the State veterinary register of the state where he is registered to the State veterinary register of the state in which he is practicing veterinary medicine on payment of prescribed fee which shall not exceed the renewal fee for registration provided such a person shall be required to produce a certificate to the effect that all dues in respect of his registration in the former State have been paid and the name of such person be removed from the first mentioned State veterinary register subject to the condition that no disciplinary proceeding is pending against him in the first state and also with the prior approval of the State Veterinary Council from whose register the applicant name was removed.

### **4) Registration of additional Qualification:**

Any registered veterinary practitioner whose name is entered in the Indian veterinary practitioners register obtains any post graduate degree or diploma in veterinary science in addition to his/her recognised veterinary qualification, may apply to the Secretary VCI on an application as prescribed to have his/her additional qualification entered in such register in addition to any entry previously made. Every application shall be accompanied by:-

- (a) Original Certificate of additional degree/diploma.
- (b) Two attested copies thereof attested by a Gazetted Officer/Principal of a recognized Veterinary College/Member of Legislative Assembly of the State within whose jurisdiction the applicant resides or a Member of Parliament.
- (c) A fee of Rs. 10 by crossed Postal Order or bank draft in the Veterinary Council of India, New Delhi.

The entries in respect of any such person in a State veterinary register shall be altered in accordance with the alternations made in the Indian veterinary practitioners register.

### **5) Issue of duplicate certificate:**

Any registered veterinary practitioner whose certificate of registration or a certificate of renewal has been lost or destroyed, he may apply for issue of a duplicate certificate in the prescribed form with the prescribed Fees, not exceeding Rs. 10 under rule 54, provided it is shown to the satisfaction of the Registrar.

### **6) Alternations of names in the Register-**

Any registered veterinary practitioner can apply to Secretary VCI with intimation to Registrar Veterinary Tribunal for alternation of name in the Register, provided, No entry in respect of alternation of the name of registered practitioner shall be made in the register unless the application is accompanied by:-

- (a) a notification in the Official Gazette relating to such alternation of name; or

(b) An affidavit regarding such alternation of name affirmed and authenticated before a Judicial Magistrate of the First Class or Metropolitan Magistrate in original, alongwith two attested copies thereof.

7) **Notification about change of place or residence:**

Every registered practitioner who changes his/her address of residence or practice shall intimate his/her new address of residence or practice to Veterinary Council of India and the Registrar Veterinary Tribunal concerned within 90 days of such change.
