Sub:- Appointment of Veterinary Pharmacist (District Cadre Rajouri) in Animal Husbandry Department, Jammu.

O R D E R

As recommended by the J&K Service Selection Board, J&K and in reference to this office Notification No:- DAHJ/Adm-1056/4536-39 Dated:- 12.09.2017, sanction is hereby accorded to the appointment of **Sh. Tosif Ahmed S/o Sh. Mohd. Saleem R/o Bathuni, District Rajouri (Category-ST)** who reported in this Directorate alongwith documents within stipulated time as **Veterinary Pharmacist** in the Pay Band of 5200-20200 + GP 2400/- in Animal Husbandry Department, Jammu (District Cadre Rajouri) against the available vacancy. The appointment of the candidate shall be regulated in terms of SRO 400 dated: 24.12.2009.

The appointee shall be initially on probation for a period of five years.

The appointee shall have to undergo one year Stock Assistant Training Course

The seniority of the appointee appointed shall reckon from the date of their appointment. The period spent on probation shall also reckon for purposes of calculating the qualifying service of the appointee provided under rules.

The appointee is adjusted against the available vacant post of Veterinary Pharmacist, ND Kakla, Rajouri.

The appointee shall report to the Chief Animal Husbandry Officer, Rajouri within a period of 15 days who will allow him to join at his place of posting only after production of following certificates/testimonials in original:-

- 1/ Academic Qualification Certificate.
- 2/ Matriculation/Date of Birth Certificate.
- 3/ Health Certificate issued by the CMO
- 4/ Permanent Resident Certificate.
- 5/ Technical Qualification, if any.
- 6/ Character Certificate.
- 7/ Relevant Category Certificate (in case of candidate belonging to reserved categories)
- 8/ Certificate from the General Manager DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.
- 9/ Undertaking on an Affidavit duly attested by the First Class Judicial Magistrate to the effect that the documents submitted are genuine and in case the documents proved fake or forged at any stage, the appointment shall be liable for cancellation ab-initio.

In case any appointee fails to join within the period of 15 days his appointment shall be deemed to have been cancelled without any further notice.



The appointment shall be subject to the following conditions:-

- a/ Each appointee shall have to give an undertaking in the shape of an affidavit to the effect that in case of any adverse report about his character and antecedents is received from the Additional Director General of Police, CID, J&K to whom a reference shall be made by the concerned DDO, the candidate shall have no right to claim his appointment as Veterinary Pharmacist and as such shall be deemed to have been cancelled ab-initio.
- b/ Verification of qualifications/Date of birth certificate from the concerned issuing authorities.
- c/ The salary of the appointees shall not be drawn and disbursed to them unless satisfactory report in respect of his character and antecedents is received from the competent authority.

This issues without prejudice to the outcome of writ petition pending if any, before any competent court of law and shall be subject to the outcome of such writ petition.
