Sub:- Selection of candidates for the post of Veterinary Pharmacist in Animal Husbandry Department, Jammu and operation of waiting list thereof.

**NOTIFICATION**

Whereas, the selection list of candidates for the post of Veterinary Pharmacists was endorsed by the Administrative Department vide letter No:- ASH/AH/NG/52/2010-II Dated:- 27.01.2017 for issuance of formal appointment orders in favour of candidates selected by the J&K Service Selection Recruitment Board against various Notifications in respect of various Districts of this Division.

Whereas, the selection list pertaining to District Reasi, against Item No: 578 (06 of 2013 Dated:- 10.05.2013) was issued by the J&K Service Selection Recruitment Board vide letter No:- SSB/Secy/Sel/2016/21059-65 Dated:- 19.12.2016, wherein candidate namely Sh. Shah Nawaz S/o Sh. Mohd. Sadiq R/o Thuroo Mahore, Reasi was selected in RBA Category.

Whereas, this office Notification No:- DAHJ/Adm-1056/10363-66 Dated:- 14.02.2017 asked the selected candidates to report this Directorate alongwith necessary documents in original before issuance of formal appointment orders.

Whereas, in response to this office Notification No:- DAHJ/Adm-1056/10363-66 Dated:- 14.02.2017, selected candidate Sh. Shah Nawaz S/o Sh. Mohd. Sadiq R/o Thuroo Mahore, Reasi selected under RBA Category reported to this office alongwith documents among other selectees within the stipulated time.

Whereas, in the meantime this office received the orders of Hon'ble High Court dated:- 13.02.2017 in the SWP No:- 264/2017 titled Mohd. Latief Chougatta v/s State through Animal Husbandry & ors through Dr.B.R.Sharma, Advocate & Legal Consultant vide his reference No:- 3103/17 MVB Dated:- 23.02.2017. The name of respondents among others includes the name of Sh. Shahnawaz S/o Sh. Mohd.Sadiq R/o Thuroo, Tehsil Mahore, District Reasi (candidate selected as Veterinary Pharmacist against Item No:- 578 by the SSRB). The order of the Hon'ble High Court dated:- 13.02.2017 is reproduced as under:-

***"Appointment to the post in question, if any, made shall be subject to the result of the writ petition."***

Whereas, this office also received an application from Sh. Mohd.Afzal S/o Sh. Ghulam Mohi Din R/o Badder, Tehsil Mahore, District Reasi who represented that the said candidate (Sh. Shahnawaz S/o Sh. Mohd. Sadiq R/o Thuroo, Tehsil Mahore, District Reasi) has played a fraud to selection board by showing fake category certificate to J&K Service Selection Recruitment Board for making his selection under RBA Category.

Whereas, after receipt of orders of Hon'ble High Court and representation of Sh. Mohd. Afzal, the formal appointment order in favour of selected candidate namely Sh. Shahnawaz S/o Sh. Mohd.Sadiq R/o Thuroo, Tehsil Mahore, District Reasi were not issued.

Whereas, Sh. Shahnawaz S/o Sh. Mohd.Sadiq R/o Thuroo, Tehsil Mahore, District Reasi submitted an application alongwith Affidavit duly attested by the Sub Judge Spl. Railway Magistrate (Judicial) Jammu is reproduced as under:

**"I, Shah Nawaz S/o Mohd Sadiq R/o Thuroo Tehsil Thuroo District Reasi do hereby solemnly affirm and edclare as under:**

- 6. That deponent is appointed as a Veterinary Pharmacist vide item no. 578 of 06 of 2013 dated 10.05.2013 through Service Selection Board of J&K State.**
- 7. That deponent now willing to leave the aforementioned job because he has been selected as a Jr. Health Inspector vide item No. 419 (04 of 2013 dated 23.02.2013).**
- 8. That deponent hereby declares that he shall not claim over the above said post in future, if anybody may appointed who already in waiting list.**
- 9. That deponent shall abide by all terms and conditions of concerned Department.**
- 10. That I am soliciting this affidavit before the concerned Department for leaving of job because the reason as mentioned above. Besides original Academic documents submitted by me in Director Animal Husbandry Department, Jammu should be returned back to me. "**

Accordingly, on his request application dated:- 12.04.2017, the documents were returned back to him.

Whereas, this office vide letter No:- DAHJ/Adm-1056/2593 Dated:- 07.06.2017 requested Administrative Department to kindly take up the matter with the recruiting agency for initiating further course of action at their end under an intimation to this department.

Whereas, after receipt of representation on 14.06.2017 from Sh.Mohd. Afzal S/o Sh. Ghulam Mohi Din R/o Bader Mahore, Reasi figuring at Sr.No: 01 in the waiting list under RBA category in the selection list of candidates for the post of Veterinary Pharmacist, District Cadre Reasi, Item No:- 578 (06 of 2013 dated:- 10.05.2013) issued by the J&K Service Selection Recruitment Board duly recommended by the Hon'ble Minister for Animal/Sheep Husbandry & Fisheries Departments, J&K for considering his case for appointment in place of Sh. Shah Nawaz S/o Sh. Mohd. Sadiq R/o Thuroo Mahore, Reasi.

Whereas, this office vide letter No:- DAHJ/Adm-1056/2842 Dated:- 16.06.2017 requested Administrative Department to kindly issue necessary instructions to this office for operation of waiting list in the RBA category on the basis of the affidavit submitted by the selected candidate Sh. Shah Nawaz S/o Sh. Mohd. Sadiq R/o Thuroo Mahore, Reasi and also keeping in view of the earlier representation of Sh. Mohd. Afzal S/o Sh. Ghulam Mohi Din R/o Badder Tehsil Mahore, Reasi whereunder he has represented that Sh. Shahnawaz S/o Sh. Mohd. Sadiq R/o Thuroo, Tehsil Mahore, District Reasi) has played a fraud to selection board by showing fake category certificate to J&K Service Selection Recruitment Board for making his selection under RBA Category.

Whereas, this office vide letter No:- DAHJ/Adm-1056/3849 Dated:- 19.08.2017 has also intimated that the SWP No:- 264/2017 titled Mohd.Latief Chougatta v/s Shah Nawaz & others stands disposed off by the Hon'ble High Court on 08.08.2017 which is reproduced as under:-

**"By instant application, learned counsel for the petitioner wants to withdraw the main petition. Dismissed as withdrawn along with connected MPs."**

Whereas, vide this office letter No: DAHJ/Adm-1056/4944 dated 22.09.2017 , once again requested to Administrative Department to kindly issue necessary instructions to this office for considering the case of Sh. Mohd. Afzal S/o Sh. Ghulam Mohi Din R/o Badder Tehsil Mahore, Reasi who is appearing at Sr.No.01 in the waiting list provided by the J&K SSRB by way of

cancelling the selection of selected candidate namely Sh. Shahnawaz S/o Sh. Mohd. Sadiq R/o Thuroo, Tehsil Mahore, District Reasi under RBA category.

Whereas, Administrative Department Vide No: ASH/AH/52/2010 dated 28.09.2017, directed this office to operate the waiting list for the post of Veterinary Pharmacist, District Reasi under RBA category in respect of Mohd Afzal S/O Ghulam Mohi Din R/O Badder Tehsil Mahore, Reasi appearing at S.No: 1 in the waiting list vis-a vis cancellation of appointment/selection of Sh Shahnawaz S/O Sh Mohd Sadiq R/O Thuroo, Tehsil Mahore, if made in consulatation with SSRB and process the case under rules.

In view of the above facts , the selection of Sh Shahnawaz S/O Mohd sadiq R/O Thuroo Tehsil Mahore is hereby cancelled abinitio and following candidate among the waiting list provided by the Service Selection Board is hereby directed to report this Directorate within a period of 21 days alongwith requisite documents so that formal appointment order are issued in his favour :-
