Subject: SOPs to be adopted for transportation of dairy animals from other States into UT of J&K

Government Order No: 95-ASH of 2020
D a t e d: 18-08-2020

J&K Government recently introduced Integrated Dairy Development Scheme which facilitates establishment of dairy units across J&K by offering 50% cost subsidy on purchase of dairy animals which are mainly procured from Punjab & other neighbouring States. Other similar scheme like Dairy Entrepreneurship Development Scheme under the auspices of NABARD is also operational in J&K.

2. As on date, there is no laid down procedure for import of dairy animals into J&K. There is a dire need to issue SOPs to streamline transportation of dairy animals so that the farmers shall not face any hardships while transporting dairy animals from outside J&K and simultaneously prevent illegal trafficking of animals.

3. Accordingly, it is hereby ordered that the following SOPs are laid down for import of dairy animals into UT of J&K:

- i. Buyer shall register at Animal Husbandry Post, Lakhanpur for purchase/transportation of dairy animals from outside J&K.
- ii. After registration, farmer shall procure the dairy animals which after reaching Lakhanpur shall be quarantined for disease surveillance & to check the health profile of animals.
- iii. After ascertaining fitness of dairy animals, they shall be tagged/vaccinated & fitness certificate issued within minimum possible time (Same day)
- iv. Simultaneously, SHO Lakhanpur shall verify the credentials of the vehicle/driver & his documents (DL, RC, Aadhar etc) & issue a verification report to the CAHO Kathua (Same day)
- v. CAHO, Kathua shall recommend the case to DM Kathua along with Health certificate & verification report of SHO, Lakhanpur for issuance of movement pass.

- vi. DM Kathua shall issue movement pass from Kathua to point of destination in J&K. DM, Kathua may delegate the issuance of movement pass to any Additional District Magistrate or SDM, Lakhanpur.
