- i. Heads of Departments shall however, re-work the 1st Time Bound eligibility in all the past cases to ensure that no undue benefit has been given to the officer(s) earlier.
- ii. The eligibility of such officers where the un-authorized period has been decided as 'Dies-non' in the past shall be reworked and the period of 'Dies-non' shall in no way be computed towards the qualifying service for purposes of determination of eligibility.
- iii. The HODs shall submit a comprehensive report to the above within three weeks.


