Sanction is hereby accorded to the temporary appointment of Smt. The appointee shall report to the Director, Animal Husbandry Department, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:-

1. Academic Qualification Certificate
2. Date of Birth Certificate.
3. Domicile Certificate.
4. Health Certificate from the Concerned Chief Medical Officer of the District.
5. Dependent Certificate issued by the Assistant Commissioner, Revenue.
6. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
7. All other relevant documents as are required under SRO-43 of 1994.

The appointment of the appointee shall further be subject to the fulfillment of following conditions:-

(a) That she shall give an undertaking in the shape of an Affidavit to the effect that:-

(i) In case adverse report about her Character and Antecedents is received from the Inspector General of Police (CID), J&K to whom a reference shall be made by the Director, Animal Husbandry Department, Jammu, she shall have no right to claim her appointment as Class-IV (Attendant) in Animal Husbandry Department and her appointment, as such, shall be deemed to have been cancelled ab-initio;

(ii) If, on verification, genuineness any of the documents/ certificates as required under SRO-43 of 1994 as amended from time to time is found fake / forged, the claim of the appointee for appointment as Class-IV (Attendant) shall also be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against her.

(b) The salary of the appointee shall not be drawn and disbursed to her unless a satisfactory report in respect of (i) and (ii) above are received in her favour.

(c) The appointee shall be initially on probation for a period of two years.

(d) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated. 24.12.2009.

(e) If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, she shall forego her right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.


