Subject: Revised Operational guidelines of Integrated Dairy Development Scheme (2021-22)

- 1. The guidelines will be in force till 31st March, 2022 or replaced by a new set of guidelines whichever is later.
- 2. The support by the department in terms of incentives/ subsidy will be available for the following:
 - a) Establishment of dairy units;
 - b) Establishment of Milk collection/chilling/processing unit;
 - c) Establishment of market infrastructure including milk ATMs; &
 - d) Establishment of milk/milk product transportation system.
 - e) Environment Management of Dairy Farms.
- 3. The scheme shall be implemented through Animal Husbandry Department Jammu/Kashmir and monitored by committee constituted by the Administrative Department for the purpose.
- 4. Mode of operation:

- i. Any individual /group of individuals/milk processing unit holders/milk federation/ retailer/ self help group/ dairy cooperative society/farmers producer organization can avail the benefits of scheme.
- ii. Efforts will be made to cover 20% SC/ST and 10% women beneficiaries.
- iii. The component wise details of benefits and subsidy available are provided at "Annexure A".
- iv. "Dairy units would mean a unit of minimum five cows/buffaloes". Subsidy is fixed for one unit of five cows/ buffaloes. However, if an entrepreneur sets up multiple units of five cows/buffaloes, he will be entitled to subsidy accordingly in multiples available for single unit of cows/buffaloes. To clarify, if a person wants to set up a dairy unit of 50 cows/ buffaloes, he will be entitled for subsidy 10 times of that available for one single unit of 5 cows/ buffaloes.

v. The cows/buffaloes shall be preferably in 2nd or 3rd lactation and in no case beyond 4th lactation and can be in advanced pregnancy or in

early lactation with calf at foot. Insurance premium may be included in cost of animal.

- vi. The dairy animals shall be inducted from outside UT of J&K so that more dairy animals will be introduced in the milk pool of J&K UT. Dairy animals shall be preferably purchased through e-pashuhaat (www.epashuhaat.nic.in) e-marketing web portal by using e-Gopala App. Animal Husbandry Department Jammu/ Kashmir shall contact all leading cattle and buffalo breeders of neighboring States and convince them to upload the details of dairy animals for sale on epashuhaat so that the intending entrepreneurs will be able to select and buy animal through the portal. All the inducted Animals shall be UID tagged & registered on INAPH web portal. The dairy animals with UID tags already procured by beneficiaries under this scheme during 2020-21 and onwards, shall not be eligible for subsidy for establishment of new dairy units under the scheme for next five years. The concerned VAS shall regularly check and update status of these animals on INAPH web portal and shall not Re-register these animals on INAPH for next five years.
- vii. The dealers of the dairy animals, if domicile of Jammu & Kashmir should have a proper registration certificate as Dairy cattle dealer and they can also upload all requisite details of dairy cows/buffaloes including source of animals on e-pashuhaat web portal. The Dairy cattle/buffalo dealers shall not be entitled for benefit under component 1 of Annexure "A" of the scheme as beneficiaries. Dairy Animal sourced from outside UT of J&K shall only be inducted under the scheme. No incentive under component "Transportation of dairy animals" (Component 1.1) of Annexure "A" shall be given, if animals are provided by a local dairy animal dealer.
- viii. The beneficiary can purchase dairy equipment from any registered company/ authorized dealer/ distributer/ sole manufacturer within or outside Union Territory of JK in accordance with minimum standard specifications in vogue as issued by the department or any central government institute. However, the rates shall be as per the company rate list or less.
- ix. The machinery/equipment should be certified as per requisite safety / quality standards and subsidy shall be released as fixed per unit by the department regardless of prices as long as specifications prescribed are met.
- x. The refrigerated milk van can be purchased as a unit or separately as chaises + refrigeration tank from authorized dealers, distributers,

manufacturers etc. The make/model of the vehicle should be mandatorily of current financial year.

- xi. Interested beneficiaries will submit their applications in the format AHD-1 to their respective Chief Animal Husbandry Officer (CAHO) who in turn after due scrutiny will submit it to the Directorate of Animal Husbandry within 15 days from the receipt of the application.
- xii. A brief business plan, indicating the site of installation/purpose/milk supply chain if any/shall be enclosed with application. Subsidy shall be extended on first come first serve basis subject to availability of funds, however establishment of large dairy units (25 to 50 dairy animals) shall be encouraged.
- xiii. Once beneficiary has procured the equipment or unit of animals, 50% of total eligible subsidy amount or of maximum ceiling, which ever is less, will be released upon submission of duly verified invoice to the Directorate of Animal Husbandry through concerned CAHO. Balance 50% subsidy will be released after physical verification by a team constituted by the CAHO concerned.
- xiv. Such verification will be carried out within 15 days of the submission of invoice and intimation that the unit has been established or equipment has been procured.
- xv. There will not be delay of more than 30 days in release of subsidy once the beneficiary has submitted the required documentation.
- xvi. Release of subsidy will be only through DBT.
- xvii. Registration of Milk van/ refrigerated milk van is mandatory before release of subsidy.
- xviii. The beneficiary can opt for loan facility by depositing 10% margin money and 50% subsidy shall be provided as back ended with defined lock in period as per RBI guidelines and terms and conditions of different commercial banks.
- xix. All such beneficiaries who intend to avail this facility shall apply in Form AHD-1 in the office of Chief Animal Husbandry Officer of concerned district along with supporting documents, if any. The CAHO shall ascertain eligibility of beneficiary before forwarding his case to concerned Directorate of Animal Husbandry for approval.
- xx. In case beneficiary avails bank loan for purchase of the equipment, CAHO shall forward the Proforma bill of the equipment along with copy of application of beneficiary and a letter to Bank. The bank shall follow all RBI guidelines for sanctioning of such loan. After receipt of NOC from Bank, CAHO shall submit the case to respective Directorate for approval and release of subsidy and as per the

conditions mentioned at point No. xvi, xi and verification of supply as per point No. xiii.

- xxi. All clarifications issued by this Department regarding implementation of the scheme are applicable to these guidelines.
- xxii. The Administrative Department will constitute a monitoring committee for monitoring the implementation and impact of the program.
- xxiii. The Director Animal Husbandry Kashmir/Jammu shall draft a uniform manual for beneficiaries which shall include checklist, all procedures involved for applying under different components of scheme as well as well documented success stories of IDDS implemented during 2020-21. They shall also submit list of beneficiaries with address/phone number and photographs along with equipment/ facility and month-wise details of utilization of subsidy to the Administrative Department. They shall also upload the same on official website.
