




- 1/ Academic Qualification Certificates.
- 2/ Date of Birth Certificate.
- 3/ Health Certificate from the concerned Chief Medical Officer.
- 4/ Dependent Certificate issued by the concerned Competent Authority.
- 5/ Character Certificate.
- 6/ Certificate from the General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan under Self Employment Scheme has been taken.
- 7/ Domicile Certificate issued by the concerned competent authority.
- 8/ All other relevant documents as are required under SRO-43 of 1994.

The appointment of the candidate shall be subject to the following conditions:-

- a/ The appointee shall give an undertaking in the shape of an Affidavit to the effect that if on verification, genuineness of the qualification and date of birth certificates produced by the appointee are found fake/forged, the appointment of the appointee shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
