
The engagees hired shall report to Directorate of Animal Husbandry, Jammu within a period of 21 days from the date of issuance of this order, failing which order of hiring of defaulting candidate shall be cancelled.

The candidates shall be allowed to join only on production of following certificates/documents (in original) to be verified subsequently:

- 1/ Academic/Qualification Certificates.
- 2/ Matriculation/Date of Birth Certificate.
- 3/ Health Certificate from the concerned Chief Medical Officer of the District.
- 4/ Domicile Certificate issued by the Competent Authority.
- 5/ Valid Category certificate, if any, applicable on date of joining.


The hiring of above candidates shall further be subject to the following conditions:-

- 1/ The period of hiring is extendable to a maximum of two years;
- 2/ The nature of hiring is purely temporary and no claim for regularization/ absorption shall be entertained to which effect candidate shall furnish an



- undertaking on judicial stamp paper duly attested by the Ist Class Magistrate;
- 3/ The services shall be utilized strictly as per the guidelines of the ESVHD-MVU Scheme.
 - 4/ The attendance shall be monitored by the concerned Chief Animal Husbandry Officer on daily basis which shall be communicated to Chief Executive Officer, Livestock Development Board, Jammu by 25th of every month.

The hiring of above candidates shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
