

Whereas, Chief Animal Husbandry Officer, Udhampur vide letter No:- CAHOU/E-08/1256-1259 dated:- 03.06.2023 has forwarded her resignation application;

Whereas, Chief Animal Husbandry Officer, Udhampur vide this office letter No:- DAHJ/Adm-25/2021-05/2622 dated:- 14.08.2023 was directed to intimate the status of RDA/Vigilance Case/Outstanding, if any, against Ms.Roshi Sharma and also furnish the last pay drawn certificate in her favour duly authenticated;

Whereas, Chief Animal Husbandry Officer, Udhampur vide letter No:- CAHOU/E-08/2287 dated:- 18.08.2023 has intimated that "there is no complaint/RDA/Vigilance case/Outstanding pending against Ms.Roshi Sharma, Attendant" and also furnished Last Pay drawn certificate wherein salary has been paid to her upto 25.05.2023.
