



Subject: Banning of import of bovines into UT of J&K and inter-District movement of bovine animals in view of spread of Lumpy Skin Disease.

Government Order No: 175-JK(APD) of 2022

Dated: 25-08-2022

In the wake of spread of Lumpy Skin Disease (LSD) in UT of J&K and some States of the Country, as a measure of abundant precaution and in view of declaration of 9 districts of UT of J&K as "Controlled Area" for Lumpy Skin Disease vide S.O 408, dated 25.08.2022 and in exercise of powers conferred under Section 10 of the Prevention and Control of Infectious and Contagious Diseases Act, 2009, Government of UT of J&K imposes complete ban on import of bovine animals from neighbouring States and inter-District movement of bovines within UT of J&K for any purpose with immediate effect, till 25.09.2022. The decision will be reviewed based on the evolving situation.
