Pursuant to approval conveyed by the Administrative Department vide letter No:- ASHF-AH0NGAZ/37/2021-03 dated:- 23.11.2023 regarding relaxation in Qualification bar and receipt of Character and Antecedents verification report from CID vide EVS Form No:- 88448 dated:- 21.11.2023 endorsed by the Administrative Department vide letter No:- ASHF-AH0NGAZ/8/2023 dated:- 05.01.2024, sanction is hereby accorded to the temporary appointment of Sh. Ravi Kumar S/o Late Sh. Ashok Kumar (Ex. Attendant) R/o Patyali Chak, PO Sangrampur, Tehsil Marh, District Jammu as Class-IV (MTS) – Divisional cadre, Jammu in the Pay Scale 14800-47100 Level: SL1 under SRO-43 of 1994 Dated:- 22.02.1994.

The appointee shall report to Directorate of Animal Husbandry, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates (in original) to be verified subsequently:

- 1/ Academic Qualification Certificate.
- 2/ Date of Birth Certificate.
- 3/ Health Certificate from the concerned Chief Medical Officer.
- 4/ Dependent Certificate issued by the concerned Competent Authority.
- 5/ Character Certificate.
- 6/ Domicile Certificate issued by the concerned competent authority.
- 7/ Valid relevant category certificate, if any, applicable.
- 8/ Affidavit as per Circular No:- 06-JK(GAD) of 2023 dated:- 06.02.2023 with the contents:-


"That if the candidate has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile district, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery".

9/ Any other relevant documents as are required under SRO-43 of 1994.

The appointment of the candidate shall be subject to the following conditions:-

- a/ The appointee shall give an undertaking to the effect that if, on verification, genuineness of the qualification, date of birth, Domicile & relevant category certificates from the concerned issuing authority are found fake/forged, the claim of the appointee for appointment as Class-IV (MTS) shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.
- b/ The salary of the appointee shall not be drawn and disbursed to him unless satisfactory reports in respect of genuineness of Qualification, Date of birth, Domicile certificates & relevant Category certificate, if any, are received from the concerned Competent Authorities.
- c/ The appointee shall be on probation for a period of minimum two years.
- d/ The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated:- 24.12.2009.
- e/ If the appointee fails to join within a period of 21 (twenty one) days from the date of issuance of this order, his appointment shall be deemed to have been cancelled ab-initio without any further notice as per the Circular No:- 08-JK(GAD) of 2019 Dated:- 04.12.2019.
- f/ The inter-se-seniority of the appointee in the J&K Animal Husbandry (Subordinate) Service shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

This order is, however, subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
