In terms of the J&K compassionate Appointment Rules, 1994 notified vide SRO-43 Dated:- 22.02.1994 recast vide SRO 201 of 2007 dated 4-6-2007, sanction is hereby accorded to the temporary appointment of Sh. Sahil Sharma S/o Lt Sh. Ram Paul Sharma, Ex- Driver R/o Kanhal Upper Tehsil Bishnah District Jammu as Attendant (Class-IV) in the pay scale of Rs.4440-7440 plus Grade pay Rs.1300/- (Pre-revised), revised pay level SL1 (14800-47100) as his father who was working as Driver has died in harness on 28.11.2018.

The appointee is posted as Attendant against the available vacant post in the office of Poultry Geneticist, Belicharana, Jammu.

The appointee shall report to Poultry Geneticist, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production and verification of the following documents/certificates.

The appointment shall be subject to the following conditions:-

- 1/ Academic Certificates.
- 2/ Date of Birth Certificate.
- 3/ Medical fitness certificate.
- 4/ Permanent Resident Certificate.
- 5/ Character Certificate.
- 6/ Certificate from the General Manager DIC concerned and Deputy Director Employment concerned to the effect that no loan under self employment scheme has been taken.

The appointment shall be subject to the following conditions:-

- a/ The appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his character and antecedents is received from the Additional Director General of Police, CID, J&K, to whom a reference shall be made by the DDO, the candidate shall have no right to claim his appointment as Attendant (Class-IV) and his appointment as such shall be deemed to have been cancelled ab-initio.
- b/ The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of character and antecedents is received from the Competent Authority.
- c/ Verification of qualification/Date of Birth certificate from the concerned Issuing authorities.
