

Terms and Reference for the Committees:

1. The Committees shall visit all the affected districts and shall assess the ground level situation, pattern of spread of disease in each district,

- recovery rate of animals, status of awareness among people about the disease.
2. The committee shall suggest the area wise preventive measures to be adopted for controlling the disease.
 3. The committee shall devise the vaccination strategy for each affected area / District.
 4. The Committees shall hold regular online meetings with field functionaries of affected districts and advise them about best practices, preventive measures and treatment protocols for controlling the disease.
 5. Director Animal Husbandry Jammu/ Kashmir shall provide all necessary inputs regarding Lumpy Skin Disease as may be required by the Committees.
 6. The Chairperson can co-opt any person as member of the Committee whose services could be utilized for controlling the spread of disease.
 7. Both the committees shall meet on daily basis at 4.00 p.m to assess the status of disease.
 8. The Committees shall submit a weekly report and present the same to Agriculture Production Department on every Monday.


